Works on Bridgwater Road

We will be removing the temporary bridge protection on Bridgwater Road **from 8 to 12 April 2024** during our core working hours of Monday to Friday 8am to 6pm. The temporary bridge protection was put in place while the tunnel boring machine passed through this area.

The road will be closed to traffic at the bridge throughout this week, with traffic management in place 24 hours a day. A clearly signposted diversion route will be in place during these works.

We will install a tower scaffold and scissor lift within the work areas shown on the map overleaf so that we can carry out the removal safely.

How these works might affect you

There will be a road closure at the bridge so that we can work safely.

We would like to apologise in advance for any disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way and we will ensure that disruption is kept to a minimum.
